



TERMS AND CONDITIONS

SALOMON ZUGSPITZ ULTRATRAIL POWERED BY LEDLENSER VIRTUAL EDITION 2020

§ 1 Area of application – validity

- (1) The ZUGSPITZ ULTRATRAIL VIRTUAL EDITION is an event of the PLAN B event company GmbH.
- (2) Changes to the terms and conditions will be published online at (HOMEPAGE). These terms and conditions (in the version valid at the time of registration) form part of the contract between the organiser and the participant.

§ 2 Conditions of participation – public health measures

- (1) All healthy, experienced and well-trained runners are eligible to participate. Participants must run on their home trails and must NOT run on the courses of the ZUGSPITZ ULTRATRAIL. Participants bear full personal responsibility for their own state of health. Anyone who has completed the registration process fully and correctly can take part. Participants who are not yet of age must be registered by a legal guardian. In this case, the legal guardian bears full personal responsibility for the underage participant.
- (2) While running, all participants must adhere to the public health measures currently in place to restrict the spread of the coronavirus. This applies in particular to the rules on social distancing as well as to the rules on social gatherings if several participants intend on running the event together.
- (3) All regulations, notices and guidelines contained in the event description text and in any supplementary instructions shall constitute a direct contractual obligation of the participant. Claims of any kind related to the contract or the services rendered by PLAN B event company GmbH must be made by participants to the PLAN B event company GmbH after the end of the event within one month after the contractually agreed end of the ZUT VE.

§ 3 Registration

- (1) Registration is only possible online via the homepage.
- (2) Participation in the ZUT VE is free of charge.

§ 4 Cancellation of the event

- (1) If the event is cancelled due to force majeure or for reasons beyond the control of the organisers, participants shall have no claim to compensation for any costs or damages.

§ 5 Liability disclaimer

- (1) By registering, participants commit to taking part in this event of the PLAN B event company GmbH.
- (2) Claims for damages by participants towards the organiser, regardless of the legal basis, are excluded.
- (3) The organiser is also not liable for technical hardware or software errors, unsuccessful or incomplete internet transmissions or other malfunctions of any kind that prevent participants from communicating their distance run and the corresponding time to the organiser.
- (4) By signing the registration form, participants declare that they are taking part in the event at their own risk and that they are sufficiently insured against accidents.
- (5) The organiser assumes no liability for health risks to participants in connection with this event. Participants bindingly declare that, at the point in time when the event begins, they have no health-related issues which are not compatible with participation in such an event and that they have the requisite fitness levels and running skills to meet the requirements of such a race. Participants must ensure themselves that their equipment is in full working order.
- (6) The organiser is not liable for any reduction in performance resulting from participants being prevented from participating in whole or in part due to legal regulations and/or official orders.
- (7) If participants or the organiser calls on the services a third party, e.g. medical aid, any costs incurred in this regard shall be borne by participants themselves, or participants shall reimburse any costs incurred by the organiser.

§ 6 Collection and use of data

(1) By registering, participants give their consent for the data needed for timekeeping, finishing places and results (as set out in the registration) to be recorded, passed on to third parties and published on the internet.

(2) The personal data provided by the participant upon registration will be stored and processed only for the purposes of organising and managing event. This applies in particular to the data required for processing payments (§ 28 German Data Protection Act). By registering, participants agree to their personal data being stored for this purpose.

(3) Participant give their permission for the photos, film recordings and interviews made in connection with their participation in the event to be distributed and published via radio, television, print media, books, photomechanical reproductions (films, video cassettes, etc.) without participants being entitled to remuneration. In addition, participants agree to their personal data being disclosed for the purpose of sending photos of the participants. These photos will be produced by a company contracted by the organiser. However, participants do not hereby declare that they necessarily wish to purchase such a photo.

(4) Participants agree to the publication of their name, first name, year of birth, team name, start number and results (finishing place and times) in all print media relevant to the event (list of participants, list of results, etc.) and in all electronic media such as the internet.

(5) Participants may object to the disclosure and publication of their personal data by contacting the organiser in writing, by fax or by e-mail.

(6) By providing their email address, participants agree to be contacted with information by the PLAN B event company GmbH.

§ 7 Limitation period

Any claims of participants towards the PLAN B event company GmbH, irrespective of their legal basis, shall become statute-barred one year from the contractually agreed end of the event.

The place of jurisdiction for any disputes arising from the contract concluded with participants is Munich, Germany. The entire legal and contractual relationship between the PLAN B event company GmbH and the participant shall be governed exclusively by German law.
