#### **GENERAL TERMS AND CONDITIONS**

#### **LOWA TRAIL TROPHY 2025**



#### § 1 APPLICATION - VALIDITY

- (1) The LOWA Trail Trophy (hereafter referred to as LTT) is an event organized by the PLAN B event company GmbH.
- (2) Current changes of the terms and conditions will be published online at www.trail-trophy.com. They are part of the contract between the organizer and the participant in the version valid at the time of registration.

#### § 2 CONDITIONS OF PARTICIPATION - SAFETY MEASURES

- (1) All healthy, experienced and well-trained runners who have reached the age of 18 are eligible to participate. Each participant bears full personal responsibility for his or her state of health. Anyone who has duly registered and is in possession of an official LTT start number can participate.
- (2) The organizer will announce organizational measures to the participants before the start of the event. The instructions of the organizer and his appropriately identified personnel must be followed. In the event of violations that could disrupt the proper course of the event or endanger the safety of the other participants, the organizer is entitled to exclude the person concerned from the event at any time and/or to pronounce disqualification. Legally binding statements towards the participants can only be made by the organizer's authorized personnel. The participant explicitly agrees to accept and strictly follow the Covid-19 measures of the organizer and the authorities during the event!
- (3) All regulations, notes and specifications contained in the announcement and in additional instructions constitute a direct contractual obligation of the participant. Claims of any kind related to the contract or the services provided by PLAN B event company GmbH must be asserted by the participant to PLAN B event company GmbH within one month after the contractually scheduled end of the LTT.

# § 3 REGISTRATION - PARTICIPATION FEE - TERMS OF PAYMENT - CONFIRMATION OF REGISTRATION - REGISTRATION CHANGE - CANCELLATION - REIMBURSEMENT - INSURANCE - DISTRIBUTION OF START NUMBERS

- (1) Registration can only be done online at www.trail-trophy.com. Registration is binding for the participants. After completing the registration, the participants will receive a confirmation including a payment confirmation. A binding contract for participation in the event is only concluded upon receipt of this confirmation.
- (2) The participation fees for the LTT are: -> from February 1, 2025
  - Single starting place: €530 -> €580

The exact scope of services included in a starting place can be found at www.trail-trophy.com. The booking of additional services, is binding and must be paid for in advance as part of the online registration.

- (3) The participation fee can be paid in three different ways
- PayPal / Credit Card / SEPA direct debit
- (4) The organizer will send a confirmation of registration to the participants after receipt of the registration and the participation fee. The organizer reserves the right to disqualify and/or exclude a participant from the event at any time if the participant has provided false personal data at registration, is subject to a ban by an international/national association, or if there is suspicion that the participant is taking part after taking unauthorized substances (doping).
- (5) The PLAN B event company reserves the right to exclude the participant from the event and/or to terminate the contract with the participant if:
  - the participant violates the regulations and/or rules and instructions (before or during the event).
  - he disturbs the event persistently or endangers himself or others.
  - he does not follow the instructions of the event management or its employees.
  - he acts in breach of contract to such an extent that the immediate termination of the contract is justified.

If the PLAN B event company GmbH terminates the contract with the participant, it retains the claim to the participation fee.

- (6) Participation can only be transferred to a third party once in agreement with the organizer until 18.05.25 for a fee of Euro 50,00. A transfer after this date is no longer possible.
- (7) The following cancellation conditions apply:
  - If canceled by March 31st, 2025, participants will receive a refund of 50% of the entry fee.
  - After this deadline, the entry fee will not be refunded.

Refunds will be made within ten business days of receipt of the written cancellation.

It is **recommended in advance** that participants **take out private** travel cancellation **insurance** and/or ticket insurance, and it is also advisable to take out insurance that includes mountain rescue.





- (8) A cancellation of the present registration by the participant can only be made in writing.
- (9) When registering, participants will receive their starting documents only upon handing over their personalized Disclaimer and their ID. The starting number will be issued only to the participant in person.

#### § 4 CANCELLATION OF THE EVENT - NON-PARTICIPATION

- (1) If the event or individual stages are canceled due to force majeure (e.g. bad weather, pandemics), or if the race is not started or is abandoned for reasons beyond the control of the organizers, the participant is not entitled to a refund/partial refund of the entry fee or compensation for other damages such as travel or accommodation costs.
- (2) Registered participants who do not show up at the starting line or who declare their non-participation to the organizer prior to the event are not entitled to a refund of the participation fee or to the delivery of the starter package.

#### § 5 LIABILITY DISCLAIMER

- (1) By registering, the participant bindingly registers for the event of the PLAN B event company GmbH chosen by him and assures, without further examination by the organizer, that he has the special previous experience and knowledge mentioned in point 1 of the regulations.
- (2) Claims for damages against the organizer by the participant, regardless of the legal basis, are excluded. This does not apply if the organizer, his legal representatives or agents have acted intentionally or with gross negligence, or for damages for which the organizer is responsible, such as injury to life, limb, health or essential contractual obligations, where liability is mandatory.
- (3) The participant agrees to submit to any checks ordered by the organizer. The participant is familiar with and fully accepts the conditions of participation and the valid regulations. He expressly declares that he has fully read and understood all the rules, regulations and conditions contained therein.
- (4) By signing, the participant declares that he is participating in the event at his own risk and that he is sufficiently insured against accidents (including abroad).
- (5) The organizer assumes no liability for health risks of the participant in connection with participation in this event. The participant declares with the start of the event that there are no health concerns regarding his participation and that his conditional level of performance and his running skills meet the requirements of such an alpine endurance competition. He is responsible for ensuring that his equipment is in perfect condition in accordance with the regulations.
- (6) The organizer assumes no liability for lost valuables, clothing, equipment during the event week and during the baggage transport (garment bag, drop bags, pannier, etc.).
- (7) The organizer is not liable for any reduction in performance that may occur as a result of the participant being prevented from participating in whole or in part due to legal regulations and/or official orders.
- (8) If the participant or the organizer commissions third parties, e.g. to alert the emergency services, the costs incurred are to be borne by the participant themselves, or the organizer has the right to collect any costs incurred from the participant.
- (9) It is highly recommended that you take out private international health insurance that also covers helicopter operations and return transportation.

## § 6 DATA COLLECTION AND USE

- (1) By registering, the participant agrees that the data provided in the registration form may be collected for timekeeping, placement and results and may be passed on to third parties and for publication on the Internet.
- (2) The personal data provided by the participant at registration will be stored and processed only for the purposes of conducting and processing the event. This applies in particular to the data necessary for payment processing (§ 28 of the German Federal Data Protection Act). By registering, the participant consents to the storage of the data for this purpose.
- (3) The participant agrees that photos, film recordings and interviews made in connection with his/her participation in the event may be distributed and published on the radio, television, in print media, books, social media (Facebook, Instagram, event website, PLAN B homepage, Youtube, etc.) without any claim for compensation. Furthermore, the participant agrees to the disclosure of his personal data for the purpose of sending photos of the participant, which are produced by a company commissioned by the organizer. However, the participant does not hereby declare that he wishes to purchase such a photo.
- (4) The participant agrees to the publication of his/her name, first name, year of birth, team name, starting number and results (placements and times) in all event-related print media (list of participants, list of results, social media, etc.) and in all electronic media such as the Internet.
- (5) The participant can object to the disclosure and publication of his/her personal data to the organizer in writing or by email.
- (6) By providing his e-mail address, the participant agrees that the PLAN B event company GmbH may use it to send him information.





## § 7 LIMITATION

Claims of the participant against the PLAN B event company GmbH, regardless of the legal basis, become time-barred one year after the contractually scheduled end of the event.

The place of jurisdiction for disputes arising from the contract concluded with the participant is Munich. The entire legal and contractual relationship between the PLAN B event company GmbH and the participant is subject to German law.
