TERMS OF USE 2025

§1 The test object and its intended use

- 1. By accepting the rented e-bike (after a functional test), the testing person acknowledges that the e-bike is in a fault-free, clean, proper, roadworthy, and usable condition.
 - a. The testing person uses the test e-bike at own risk.
 - b. By signing the testing person assures that there has been an instruction in the proper use of the test e-bike.
 - c. Furthermore, by signing the testing person assures to be sufficiently informed about the use of protective devices (e.g. helmets) and clothing when using the test e-bike.
- 2. The testing person may only use the test e-bike in a customary manner and in compliance with the statutory provisions, in particular the German road traffic act and the German road traffic licensing regulations.
- 3. A transfer to third persons is explicitly prohibited.

§2 Identification

In order to rent a test bike, it is required to identify with an official document (ID, passport, driver's license - not older than 10 years) when registering. The authenticity can be verified randomly with the help of the police. By signing the testing person authorizes that the organizer copies this document and keeps it together with the registration form.

§3 Responsibilities of the testing person

- 1. The testing person is obliged to handle the test e-bike carefully and in compliance with the usage instructions.
- 2. The testing person is obliged to report any defects occurring during the rental period without being asked.

84 Accident

The testing person is obliged to notify the e-bike rental company in case of the test object (e-bike, helmet) is involved in an accident and third persons are injured or the test e-bike has been stolen. In case of an accident, the testing person must submit a detailed written report to the rental company including a sketch of the accident area. The report of the accident must particularly contain the names and addresses of the involved persons and any witnesses as well as the official registration numbers of any vehicles involved (if applicable). In case of the testing person fails to comply with this obligation to report, the testing person shall be liable to the rental company for any damage resulting from the violation of this obligation.

§5 Liability

- 1. The rental company of the test e-bike is only liable for intent or gross negligence. The rental company is not liable for any damages resulting from unauthorized and/or improper use of the test e-bike.
- 2. The testing person has to return the e-bike in the same condition in which the bike was taken over. The testing person is also liable for damages resulting from theft, damage, partial loss and/or loss of the test e-bike during the time between taking over the test object from the rental company and its return.
- 3. The testing person is liable for culpable damage of the test e-bike and for the violation of contractual obligations. The incidental costs of the damage must be reimbursed afterwards.

§6 Return of the test e-bike

The testing person must return the test e-bike to the rental company latest at the agreed time. The testing person is liable for loss and/or damage to the rental object.

§7 Data protection regulations

- 1. By signing the testing person agrees that the organizer may use personal data for statistical purposes and may pass on these statistics to official exhibitors at the event.
- 2. The testing person agrees to the publication of image and video material taken on the event. By providing the email address, the participant agrees that PLAN B Sport Marketing GmbH may use it for sending information or surveys.

§8 Bracelet

The bracelet must be worn during the event and is absolutely required for renting. It is forbidden to hand it over to third peron.
