

CONDITIONS OF PARTICIPATION / DISCLAIMER / DATA COLLECTION

Conditions of participation

The Heilbronn Trollinger Marathon is held in accordance with the regulations of the IAAF (IWR) and the German Athletics Association (DLV, DLO). It is open to club and recreational runners. Participation is at your own risk. The organizer or host accepts no liability for accidents or theft. Minors may only register with the consent of a legal guardian (parent).

Marathon: Runners born in 2008 and older are eligible to participate.

Half Marathon: Runners born in 2010 and older are eligible to participate.

Relay marathon: Runners born in 2010 and older are eligible to participate.

Duo Marathon: Runners born in 2010 and older are eligible to participate.

10 km run: Runners born in 2014 and older are eligible to participate.

Walking/Nordic-Walking (8.7 km): Walkers born in 2014 and older are eligible to participate.

Zehnteleslauf (hobby/leisure run over approx. 4.2 km): Runners born in 2016 and older are eligible to participate.

Only runners and walkers with the official start number of the 24th Heilbronn Trollinger Marathon or the Mini Trolli are allowed to take part. The start number is not transferable. It must be worn clearly visible and unchanged on the front of the running shirt. Costumes must be made in such a way that the start number can be seen without being affected.

By registering, each participant, or in the case of minors their legal representative declares the following by clicking on the online registration form:

Declaration/Disclaimer

"By registering and participating in the 24th Heilbronn Trollinger Marathon and the supporting events, I acknowledge the organizers' exclusion of liability for personal injury or property damage (this does not include damage caused intentionally or by gross negligence). This also applies to lost valuables. I will not make any claims against the organizers and sponsors of the race, nor against the city of Heilbronn and the participating district communities or their representatives for damage or injury of any kind that I may incur as a result of my participation in the race. I declare that I am healthy, that my state of health has been confirmed by a doctor and that I have trained sufficiently to participate in this competition. I declare that I have not taken any performance-enhancing substances that are on the WADA doping list (see www.nada-bonn.de). I agree that I will be taken out of the race if there is a risk of damage to my health. I acknowledge that I can be taken out of the race if I am slower than the announced times. If I continue running anyway, I do so at my own risk. I agree that the data I provided in my registration, the photos, film recordings and interviews I made in connection with my participation may be used in radio, television, advertising, books, photomechanical reproductions - films, etc. - without any claims for compensation on my part. I confirm that the data I have provided is correct and I assure you that I will not pass on my start number to anyone else. I am aware that I will be disqualified if I change or obscure the official start number, if I run with a baby jogger or if I am accompanied by people on sports equipment (inline skates, bicycles, etc.). I am aware that according to Rule 144 IWR (International Competition Rules), the use of radios, headphones or similar devices in the competition area is not permitted. I am aware that dogs are not permitted. If I do not attend, the event is cancelled or is interrupted due

to force majeure, I am not entitled to a refund of the organisation fee. By registering, I acknowledge that the organiser may request proof of health."

Data collection and management

The data collected during registration will be saved and processed for the implementation and handling of the event, including the purpose of providing medical care to the participant on the course and at the finish line by the medical services supervising the event. This applies in particular to the data required for payment processing. By registering, the participant consents to the permanent storage of the data. The participant agrees that the personal data collected will be passed on to third parties for the purpose of timekeeping, creating result lists and posting these lists on the Internet. In particular, the participant agrees to the passing on of his personal data (email address) for the purpose of sending photos of the participant on the course and at the finish line, which are produced by a company commissioned by the organizer. However, the participant does not hereby declare that he would like to buy such a photo. Personal data will be sent to Deutsche Triathlon gGmbH to determine a special prize draw. This data will be completely deleted after the draw has ended. The organizer/host reserves the right to use the address data to send event information. By registering, the participant also consents to the stored personal data and any other data, if applicable, being used by the medical services supervising the event in the event of medical treatment and being passed on in an anonymized form for scientific evaluation with the aim of improving the health aspects of running events. The individual medical confidentiality remains unaffected by this consent.
